The registrar of companies makes the following rules in exercise of the powers conferred by the enactments specified in Schedule 1.

Chapter 1

Introductory provisions

Commencement

1. These rules come into force on 23 July 2020 (the “commencement date”).

Status

2.(1) These rules shall be known as the Registrar’s Coronavirus Easements (Upload Service) Rules 2020.

(2) These rules are in addition to any other rules made by the Registrar under the powers conferred by the enactments specified in Schedule 1.

Definitions and general interpretation

3.(1) Defined terms used in these rules and their meanings are contained in Schedule 2.

(2) Unless the context otherwise requires-

(a) references to sections are to sections of the Companies Act 2006;

(b) a reference to a “rule” or “rules” is a reference to these Registrar’s Coronavirus Easements (Upload Service) Rules 2020 and a reference to a numbered rule or Schedule is to the rule or Schedule so numbered in these rules;

(c) references to delivering a document include submitting or sending it;

(d) a reference to an Act includes a reference to any subordinate legislation made under that Act;

(e) words in the singular include the plural and vice versa.

(3) Subject to rule 3.(4), material or information referred to in these rules as being specified, described, accessible or available on or through the website is included in and forms part of these rules.

(4) Material or information referred to in these rules as being “from time to time” specified, described, accessible or available on or through the website does not form part of these rules.

Application of these rules

4.(1) These rules apply to documents delivered to the registrar in electronic form using the upload service on or after the commencement date and shall be construed accordingly.

(2) The documents that may be delivered to the registrar using the upload service, and the entities in respect of which each document may be delivered, are specified in column 1, and the corresponding part of column 2, of the table in Schedule 3. The entities in respect of which documents may be filed using the upload service are collectively referred to in these rules as “companies (or other bodies)”.

(3) The legislative provision under which each document is delivered is specified in column 3 of the table in Schedule 3.

(4) Any restriction on the circumstances in which a document may be delivered is specified in column 4 of the table in Schedule 3.

Chapter 2

The upload service: general provisions

Using the upload service

5.(1) To deliver a document using the upload service in respect of a company (or other body) the presenter must:

(a) have access to the internet;

(b) have an email address;

- (c) be a registered user of CHS (information about the registration process is available on the website from time to time);
- (d) be able to convert the document into a compatible PDF file;
- (e) in the case of a fee-bearing document be in possession of a payment reference code (see rule 11(1)(a)); and
- (f) be or act under the authority of an authorised person.

Communications

- 6.(1) This rule does not apply to certificates issued by the registrar.
- (2) Communications from the registrar relating to or arising from the delivery of a document using the upload service shall be sent by email to the email address associated with the CHS account used to deliver the document.

Chapter 3 Form of document

Pro forma documents

- 7.(1) A document that is not a free text document must be in the form of a pro forma. The table in Schedule 4 specifies which documents are required to be in the form of a pro forma and where the pro forma is to be found.
- (2) The presenter must complete the required data input fields in the pro forma.
- (3) The completed pro forma must be converted into a compatible PDF file.

Free text documents

- 8.(1) A free text document must be converted into a compatible PDF file.

Package filings

- 9. (1) Column 1 of the table in Schedule 5 specifies if a document must be delivered as part of a package filing and Column 2 of that table identifies the other documents required to be sent in that package.
- (2) Unless otherwise specified in column 3 of the table in Schedule 5 the presenter must complete and convert each document comprised in the package filing into a separate compatible PDF file.

Chapter 4 Authentication

Authentication

- 10.(1) The presenter must by way of authentication provide the Registrar with the name and registered number of the company (or other body) to which the document(s) being delivered relate.
- (2) Where the presenter wishes to use the upload service to deliver a document identified in column 1 of the table in Schedule 6, the presenter must by way of authentication provide the Register with the digital code for the company (or other body) to which the document relates. Column 2 of the table in Schedule 6 specifies the type of digital code required in each circumstance. Information about how to obtain digital codes is available on the website from time to time.
- (3) Every digital code provided by way of authentication of a document will be indelibly linked to and retained as part of that document.
- (4) Unless otherwise set out in these rules, a person who authenticates a document must belong to, or be specifically authorised by a person who belongs to, a category or class of person specified by the registrar in Schedule 7 as being permitted to authenticate that document.

Chapter 5

Delivery and receipt

Delivery

11.(1) To deliver a document or package filing to the registrar in respect of a company (or other body) the presenter must:

- (a) whilst logged onto CHS, access the upload service and, in the case of a fee-bearing document, tender payment of the fee so as to obtain a payment reference code;
- (b) complete such data input fields as may be required in respect of the document(s) to be delivered; and
- (c) upload the presenter's locally saved copy of the document by clicking the "attach" radio button and, in the case of a package filing, the presenter must repeat this process in respect of each document in the package before the document can be delivered.

(2) The document is delivered when the presenter clicks on the "send" or "submit" radio button.

Receipt

12.(1) A document delivered using the upload service is received when it is given an automatically generated time and date stamp by the registrar's computer systems.

Schedule 2 - Defined terms used in this Volume of the rules and their meanings (rule 4.(1))

“API” means application programming interface;

“authentication code” means a confidential code agreed by the company (or other body) and the registrar;

“authorised person” means a person authorised in law to deliver a document or to cause a document to be delivered to the registrar;

“CHS” means the registrar’s on-line API gateway service of that name (also known as “Companies House Service”);

“CIC” means a community interest company within the meaning of section 26 of the CIC Act;

“CIC Act” means the Companies (Audit, Investigations and Community Enterprise) Act 2004;

“commencement date” is specified in rule 1;

“company” has the meaning given to it in section 1;

“compatible PDF file” means a file in portable document format up to a maximum of 4MB in size that when rendered into a human readable image gives the appearance of an A4 sized document completed in black ink.

“data input field” means-

- (a) a box or similarly delineated area visible in human readable form the purpose of which is to capture information; together with
- (b) the descriptor text associated with the box the purpose of which is to signify the nature of the information required to be input into the box;

“digital codes” means authentication codes, lender authentication codes, presenter authentication codes, personal authentication codes, temporary identification numbers, temporary authentication codes and digital signatures as the case may require;

“document” means information required to be or authorised to be delivered to the registrar under an enactment;

“fee” means a fee payable to the registrar by virtue of regulations or determinations made under s1063;

“fee-bearing document” means a document for which a fee is payable in respect of its receipt;

“free text document” means a document that, if delivered to the registrar in paper form, would not be required to be delivered using a pro forma;

“limited partnership” or “LP” means a limited partnership within the meaning of s4 of the Limited Partnerships Act 1907 and, for the avoidance of doubt, includes private fund limited partnerships;

“LLP” means a body corporate incorporated as a limited liability partnership under the LLP Act;

“LLP Act” means the Limited Liability Partnerships Act 2000;

“LLP Regulations” means the Limited Liability (Application of Companies Act 2006) Regulations 2009¹;

“overseas company” has the meaning set out in s1044 of the Act;

“package filing” means two or more documents that must be delivered together to the registrar;

“payment reference code” means the code generated by Gov.UK pay (or such other payment service to which the upload service is linked from time to time) to confirm the receipt of a fee;

“presenter” means a person using the upload service to deliver a document to the registrar;

“pro forma” means a blank template specified in legislation or by the registrar in rules to be used for delivering a document to the registrar in paper form;

“registrar” has the meaning given in section 1060(3);

“SE” means a European Public-Limited Liability Company (or Societas Europaea) which is within the meaning of the SE EC Regulation and which is registered in the UK;

“SE EC Regulation” means the Council Regulation 2157/2001/EC of 8 October 2001 on the Statute for a European Company;

“section 1040 company” means any of the following companies- (a) a company authorised by section 1040 of the 2006 Act to register under that section or a company registered under that section, (b) a company registered under section 680 of the Companies Act 1985, or (c) a company registered under Article 629 of the Companies (Northern Ireland) Order 1986¹²;

“SLP” has the meaning given to “Scottish limited partnership” in regulation 3(2)(a) of the Scottish Partnerships PSC Regulations;

“SQP” has the meaning given to “Scottish qualifying partnership” in regulation 3(2)(b) of the Scottish Partnerships PSC Regulations;

“unregistered company” means a body to which section 1043 of the 2006 Act applies.

“upload service” means the registrar’s electronic filing service whereby a document in the form of a compatible PDF file can be delivered to the registrar by uploading it through CHS;

“website” means –

- (a) www.companieshouse.gov.uk; and
- (b) www.gov.uk and any websites or web pages relating to Companies House which are accessed through www.gov.uk;
