The registrar of companies makes the following rules in exercise of the powers conferred by sections 1068 and 1117 of the Companies Act 2006.

Title and commencement

1. The title of these Rules is the Registrar's Nomination of Default Address Rules 2024 (Volume 6 of the Registrar's Rules) and they come into force on 4 March 2024.

Definitions

2. In this Volume of the rules –

“the registrar” has the meaning given to it in section 1060 of the Companies Act 2006;

“the Address Regulations” means the Service Address (Rectification of the Register) Regulations 2024, the Registered Office Address (Rectification of Register) Regulations 2024 and the Principal Office Address (Rectification of Register) Regulations 2024.

Application of this Volume

3. (1) The Rules nominate default addresses for the purposes of regulation 3 of the Address Regulations.

(2) Other Volumes of the Registrar's Rules cover the following matters-

- (a) Registrar's (Electronic Form) Rules 2012 (Volume 1);
- (b) Requirements applicable to documents delivered to the registrar in paper form (Volume 2);
- (c) Requirements applicable to a document or a part of a document specified in these rules that is delivered to the registrar on a CD -ROM or DVD-ROM (Volume 3); (d) Requirements applicable to instructions for the informal correction of a document delivered to the registrar (Volume 4); and
- (e) Authentication of a certificate sent by the registrar by electronic means (Volume 5).

Default addresses

4. Pursuant to regulation 3 of the Address Regulations the registrar nominates the addresses set out in column 2 of the table below as the default address in relation to any address within the jurisdiction set out in the corresponding entry in column 1 of the table, for the purpose of the Address Regulations.
